Annual Update:

When there is a change to your monthly payment, you will receive notification of the change. The Saskatchewan Teachers' Superannuation Commission

Cost of Living Allowance Increase:

Section 22 of *The Teachers Superannuation* and Disability Benefits Act provides an annual COLA for retired teachers, spousal benefit recipients and dependents. For those who began receiving payments during the 2022 calendar year, the COLA will be prorated. Allowances are adjusted (STSC) is pleased to provide you with your January 2022 Notification of Deposit. Your January payment reflects the **2023 Cost of Living Allowance** **(COLA) increase of 5.2%**, plus any changes in Federal and Provincial income tax rates.

each January 1 by 80% of the percentage increase obtained by dividing the <u>average</u> Canadian consumer price index (CPI) for the 12 months ending on the 31st day of October of the previous year by the <u>average</u> CPI for the 12 months ending on the 31st day of October one year earlier. Your annual increase is provided to help offset the effects of inflation. The 2023 COLA is the highest amount applied to superannuation benefits since 1984 when COLA was 5.4%.

2022 T4A Income Tax Slips:

The CRA T4As **are scheduled** to be mailed from the STSC **the week beginning February 6, 2023**. For those who superannuated part way through the year, you will receive a separate T4A for the group life insurance taxable benefit from when you were teaching. For those who were in receipt of a disability benefit and superannuated part way through 2022, you could

receive up to three T4As. One for your disability benefit, one for superannuate benefit and one for the group life insurance taxable benefit from when you were teaching.

Power of Attorney:

To ensure you have the proper legal authority in place if you are unable to carry out your financial instructions, you may have authorized a family member or trusted friend to be your Power of Attorney. A Power of Attorney is a legal document that gives someone else the right to act on your behalf, like managing your financial affairs in your absence. If you have provided a Power of Attorney to a trusted person, a copy of this document should be forwarded to the Commission to keep on file.

Saskatchewan Teachers' Superannuation Commission Launches New Website!

In May 2022, the STSC launched a new redesigned website to replace the former website that was developed in 2002. The new website is easier to navigate with a fresh modern look.

Items available on the website will include member forms relating to the administration of the teachers' superannuation, group life insurance plan, information on the

Commission and the teacher benefit plans it administers, links to other relevant pension and benefit websites, along with the Commission's annual reports. **Check out the new website at www.stsc.gov.sk.ca**.

Request to Confirm Receipt of Pension Payments coming in July 2023:

It's considered a best practice in the pension industry for plan administrators to periodically contact its superannuates and receive confirmation that they are indeed receiving their pension benefits. Beginning in 2017, the STSC implemented a process where each pension recipient that receives a benefit from the Teachers' Superannuation Plan will be mailed a letter every three years requesting, they confirm in writing they are receiving their pension entitlement. These periodic pension confirmations have been successful in identifying a small number of deaths that were not reported to the Commission resulting in pension payments continuing to be paid to people not entitled to receive the benefit. In these cases, the payments were discontinued and monies were returned to the Fund. This type of periodic validation is very important to ensure the integrity of the Plan. The primary purpose of this pension confirmation is to certify the proper person entitled to the pension benefit is receiving their payment. In July 2023, the Commission will be mailing out a letter asking pension recipients to sign and return the letter to the STSC to confirm they are receiving their pension benefits. The pension confirmation letter will include a self-addressed postage paid return envelope for each person's convenience. This project will be complete once each pension payment is successfully confirmed and reconciled. The Commission sincerely appreciates your timely response to its pension confirmation request. **Please** watch for the pension confirmation letter scheduled to be mailed out by the second week of July 2023.

Your Beneficiary - If you had a change in personal circumstance, it is important to update your designated nominees/beneficiaries for your pension and group life insurance. This is especially important if you have a change in a family	situation due to marriage, divorce or death. Please note common law status is only recognized under <i>The Teachers</i> <i>Superannuation and Disability Benefits Act</i> if you are not married.	A beneficiary form for group life insurance benefits will supersede a Last Will and Testament. You can find the Group Life Beneficiary and the Appointment of Nominee forms on our website.
